Purpose

The Casual Operator provides a variety of snow/ice removal, maintenance and repair services to roads, bridges, culverts, drainage and other road work, landfills, and public access points such as parking lots and landings.

Responsibilities

- Operates a backhoe, tandem and single axle truck and/or other equipment as required.
- Conducts general maintenance and manual labour functions for Public Works operations as assigned by the Public Works Supervisor.
- Provides traffic control as a flag person.
- Conducts work in compliance with all municipal and provincial Occupational Health and Safety legislation, regulations, policies and procedures. Ensures that all safety apparel is worn when required.
- Completes logs and time sheets as required.
- Operates all equipment safely and in accordance with all policy, procedures, by-laws, Ministry guidelines, regulations and legislation, and as personally licensed to operate.
- Reports any defects to machinery, property or process to the Public Works Supervisor or Operations Manager promptly. Ensures vehicles and machinery are kept in a safe, neat and tidy order.
- Performs other duties as assigned.

Knowledge and Skill

- A solid understanding of public works construction and maintenance procedures.
- A good understanding of all policy, procedures, by-laws, Ministry guidelines, regulations and legislation related to the operation of equipment and public works construction and maintenance.
- Valid Class DZ Ontario Driver's Licence with a clean abstract.
- Satisfactory police criminal record check is required.

Experience

- A minimum of two (2) years' experience operating a backhoe and tandem axle truck. Previous experience operating a combination plow sander would be an asset.

Hours of Work

Working Conditions

- Operates equipment and undertakes construction and maintenance projects in extreme weather conditions.

- Heavy physical demands related to manual labour in maintenance projects.
