## **PRICE LIST**

Effective date: January 1, 2025

**Unless otherwise specified, prices shown do NOT include applicable HST.**

The following format and content of the price list has been stipulated by the Bereavement Authority of Ontario and is required to be posted by all bereavement licensees.

## Interment Rights

Interment right prices listed below include a non-refundable contribution to the cemetery's Care and Maintenance Fund (see below). The prices listed below do not include the opening and closing of the grave, niche or memorialization costs (flat marker, upright monument, etc.) and associated installation fees.

### In-ground burials

Plots (Resident) .....	\$950.00
Plots (Non-Resident) .....	\$1900.00
Columbarium Niches (Resident).....	\$1100.00
Columbarium Niches (Non-Resident).....	\$2200.00

### Care and Maintenance Fund Contribution:

As required under the *Funeral, Burial and Cremation Services Act, 2002* and Ontario Regulation 30/11, the amounts below will be contributed to an irrevocable trust fund known as the Care and Maintenance Fund. Income (interest) from this fund is used to cover care and maintenance expenses of the cemetery in perpetuity.

For one in-ground grave (Resident).....	\$380.00
For one in-ground grave (Non-Resident).....	\$760.00
Columbarium Niche (Resident).....	\$165.00
Columbarium Niches (Non-Resident).....	\$330.00

## Interment Rights and Marker Specifications

### Interment Right for Plots

One (1) full burial (casket) and three (3) cremations OR four (4) cremations are permitted in one plot. If a full burial is to follow a cremation interment the urn containing the cremated remains must be made of non-biodegradable material in order for it to be removed at a later date for the full burial (casket) interment.

### Marker Specifications

The maximum size of monuments shall be H-48", W-24", D-8" for a single plot and H-48", W-42", D-8" for a double plot. The monuments must be placed at the head of the plot.

Monuments are to be erected by or for plot owners and shall be set upon adequate concrete bases, and no foundations shall be less than 6" in depth. The upper surface of the foundations shall extend three inches on all three sides and eight inches on the front beyond the monument base and be flush with the ground.

All foundations for monuments and markers shall be constructed by municipal employees.

### Care and Maintenance Fund Contribution:

As required under the *Funeral, Burial and Cremation Services Act, 2002*, the following amounts must be paid to the cemetery operator before a marker is installed. After each marker installation, the amount will be contributed to an irrevocable trust fund known as the Care and Maintenance Fund. Interest from the fund will be used to cover expenses for the care and maintenance of markers and monuments in perpetuity.

For flat markers measuring less than 1,116.13cm <sup>2</sup> / 173in <sup>2</sup> .....	\$0
For flat markers measuring 1,116.13cm <sup>2</sup> / 173in <sup>2</sup> or larger .....	\$100
For upright monuments 1.22m/4ft or less in height and 1.22m/4ft or less in length, including base.....	\$200
